Gas Pipeline Leak Survey

As the weather warms up, you may see one of our employees patrolling your yard with a hand-held gas leak detector. If you are unsure about a person you see in your yard, call us at 715-425-6177 to ask if we have someone on duty in your area.

Federal regulations require that all gas utilities patrol their pipelines regularly to check for underground gas leaks.

Each year we patrol all of our mains in public rights of way, including the Hammond, Prescott and River Falls downtown business districts, and one-fifth of our service lines on customer property.

The electronic leak detection equipment we use is highly sensitive. The technology senses tiny amounts of methane (the primary ingredient of natural gas).

If we find a leak, it is classified and scheduled for repair. It is rare for us to find a leak, thanks to the quality of pipe in our system and non-corrosive soils in this area.
