# Notice to customers of St. Croix Valley Natural Gas

## **Rate Case hearing**

St. Croix Valley Natural Gas Company, Inc. (St. Croix Gas) filed an application with the Public Service Commission of Wisconsin (PSCW) on April 15, 2022 for authority to increase its natural gas rates. The Company filed at this time due to increased cost of operations since 2020.

The Company is requesting an overall increase in revenues of \$551,600 annually, or approximately 4.8% over 2020 rates. The impact of the Company's proposal on a residential customer using 832 therms annually would average approximately \$3.33 monthly, or \$40.00 per year. Final rates may vary from those proposed by the Company and will be determined by the Commission.

**Public Hearing**. A hearing on the Company's application will be held on Wednesday, Feb. 22, 2023 at 4:00 PM. This will be a Zoom hearing hosted by the PSCW. Persons wishing to participate may attend by computer at https:// us02web.zoom.us/my/pschearings. If you do not have an internet connection, you can join the hearing by telephone by dialing (312) 626-6799. When prompted, enter the meeting ID: 809 513 2930. A Zoom connection will be available at the Company's office for those without access to a computer or telephone. **Web Comment:** File a comment on the internet. Go to the Commission's website at http://psc.wi.gov, click the dropdown menu labeled "Commission Action", select the item labeled "File a Public Comment". On the next page select the "File a comment" link that appears for docket number 5230-GR-109. Web comments shall be received no later than February 24, 2023.

**Live Comment.** Make a live comment live at the hearing. The Administrative Law Judge (ALJ) may receive live comments from any member of the public in attendance after the close of any party and Commission staff testimony. The ALJ will receive such comments by stating the name of each member of the public connected to the hearing, one at a time, and asking if they would like to comment.

## U.S. Natural Gas market price forecast: Down 25% in 2023

The U.S. Energy Information Administration predicts a decline of approximately 25% in natural gas prices in 2023 compared to 2022. Domestic use is expected to continue to decline and liquid natural gas exports to remain relatively flat.

This is the cost of the commodity itself, not the rate for delivery charged by St. Croix Gas.
