Each Budget Plan is customized for the customer's actual usage over 12 months' time. It is adjusted in February and July to reflect your actual usage and changes in natural gas prices.

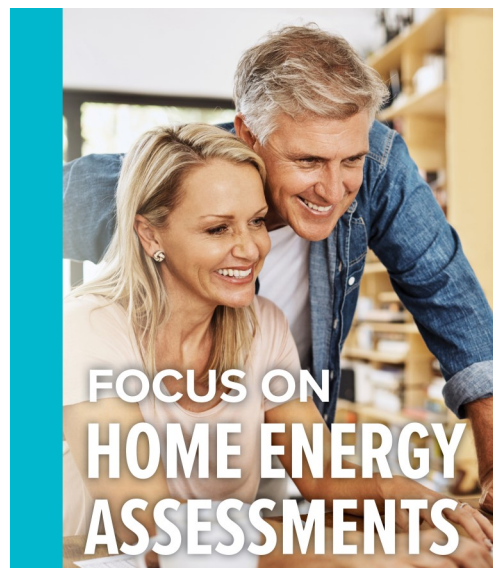
